Chair's Report



It's with pride and pleasure that I present my report for the past year during which we have moved forward as a company in a sound position to grow and develop for the future sustainability of Wounds Australia.

Blake Wilson, the CEO of Wounds Australia joined us in April 2019, is committed to delivering the organisation's key priorities. Three key priorities were agreed by the Board to set the directions for the organisations and to inform objectives the Wounds Australia pursue into the future. The focus of the priorities is to determine the current financial viability, develop responsible initiatives for sustainable financial status and establish strategies to ensure that ongoing financial viability of Wounds Australia.

Despite the challenges associated with the transition to a national entity, I am pleased to note that the activities of the Wounds Australia continued apace, as evidenced by the achievements outlined in this Annual Report.

The Wounds Australia's Biennial Conference 2018 was considered as the best conference since we became a national entity. Through a joint effort by the conference committees, Wounds Australia Board and Conference PCO, the 2018 conference was a great success - educationally, financially and through beneficial networking.

Wounds Australia has forged a strong and successful relationship with the Commonwealth Government. We will have a major role in the \$2 million scoping study in primary healthcare networks; we had an opportunity to provide Wounds Australia's contribution through a submission to the Medicare Benefits Schedule (MBS) Review Taskforce to review the current MBS items relating to the management of chronic wounds. We were invited to take part in a round table discussion of the draft report and had the opportunity to further enhance the document to go the the governmanet. Wounds Australia also presented a submission to the Royal Commission on Ageing and as a result we were required to appear before the Royal Commission to give evidence. Another fantastic outcome for our members this year is the completion of the Wounds Australia Credentialing Program to be launched at the AGM in 2019 in Bendigo Conference. A range of benefits for health professionals, patients, community and health services will be achieved with the program. The inception of the program acknowledges the recognition of professional knowledge, experience, and scope of practice in wound management of our members.

The annual "Wound Awareness Week" in July 2018 was a great success. Wounds Australia's message was proudly delivered with significant media coverage, interacting with politicians and engaging more clinicians in this event around the country.

On behalf of the Board, I would like to take this opportunity to thank the previous Chair of the Board Kylie Sandy-Hodgetts and the previous CEO, Anne Buck for their contribution to Wounds Australia.

I particularly would like to thank the Board for their commitment to the governance of the Wounds Australia through volunteering their time and skills, and for their ongoing support of me in the capacity of Chair. I would like to acknowledge the hard work and dedication of the Wounds Australia staff who have continued to progress activities towards achieving its goals. In particular I would acknowledge the outstanding assistance given to me and Wounds Australia during the interim period before the appointment of our CEO by Sriyani Ranasinghe and all of the staff in the office to ensure the continued functioning of the company. As the company moves into another year there will continue to be considerable change as we face transition challenges in a climate of fiscal constraint. I am confident that the members of Wounds Australia, volunteers, Board, and staff will continue to work together to find effective ways to meet our agreed priorities and to remain relevant and effective. I would like to thank the memberships and the board for giving me the privilege of being chairman over the past year. 


MEMBERS BY QUARTER (2018 - 2019)



MEMBERSHIP BY STATE






The aim of the Wounds Australia Research Portfolio is to be recognised as the Quality Leader for Research. The portfolio facilitates Wounds Australia to develop and support wound-related research activities for the benefit of all Wounds Australia members.

The Research Portfolio has now become the Research Committee, with all Portfolio members continuing on in the new Committee. The terms of reference are being reviewed. There are currently 12 members, but Charne Miller has flagged that she will resign in July 2019, to concentrate on her role as head of the Scientific Committee for the 2020 Wounds Australia National Conference.

Three 2018 biennial research grants (\$20,000 in total) were awarded at the 2018 National Conference. The results will be presented at the 2020 Annual Conference, and will also be published in Wound Practice and Research. A member of the Committee will act as a mentor to assist the awardees in achieving milestones.

An additional \$5,000 grant for a document scoping research gaps and methodologies to address these resulted in a final report (28 August 2018), published in Wound Practice and Research (2019; 27(2):62-107). This will now be considered by the Committee to set research priorities and ways the Committee can support research in Australia and our region. A draft 5-year plan has been developed.

Fundraising remains a priority and the Committee is working closely with the Wounds Australia Board to enhance this. Our relationship with industry remains pivotal in this endeavour.


Wounds Australia Aseptic Technique Technique Project

Aseptic technique committee was dedicated to updating the second edition of the publication during this financial year. The second edition was published in October 2018. The document was presented at one of the workshops held at the Wounds Australia National Conference 2018. The following feedback received from the workshop is being incorporated into a revised version.

- Development of educational resources to support and guide clinicians in implementing the Wounds Australia Aseptic Technique in Wound dressing procedure consensus document into clinical practice.
- The educational resources should include the PowerPoint presentation that facilitates the delivery of standardized key messages.
- The educational resources should also include two posters providing graphics and necessary supporting text on Open-but-unused dressings and washing of a limb.

The consensus document is currently being reviewed in order to incorporate the feedback received from the workshop. The revised document will further support to members and clinicians to optimize outcomes for persons who receive wound care.

The sub-committee would like to thank the delegates who attended the workshops on Aseptic Technique in Wound Dressing Procedure at the Conference and the attendees who have evaluated the posters.

Wound Practice and Research Journal

Wound Practice and Research is the official journal of Wounds Australia and publishes original peer-reviewed papers that address the issues that underpin wounds, wound healing and tissue repair.

This year the journal has continued its primary purpose of publishing high quality, peer-reviewed articles that reflect the interest of its readership which is primarily around education, wound care in the community and the aetiology of acute and chronic wounds. This year also saw one of our themed issues highlight the outcomes of research that was undertaken by awardees of Wounds Australia research grants. The purpose of these grants is to support studies in the areas of prevalence and cost-effectiveness research, impact on quality of life, risk factors for delayed healing, support surfaces and pressure injury prevention, compression therapy, dressings and innovative new therapies, and infection and symptom management.

By publishing these studies in Wound Practice and Research their outcomes can be easily disseminated to our readership of Wounds Australia members and more broadly through exposure through online search engines including CINAHL, Google Scholar and Informit. Additionally, every article published in WPR is now given a Digital Object Identifier (DOI) which is a unique alphanumeric string assigned by a registration agency (the International DOI Foundation) to identify content and provides a persistent link to its location on the internet. Our publisher, Cambridge Media, now assigns a DOI to every article that we publish. DOIs allow the efficient management and accurate tracking of an article, as well as helping our articles gain visibility, and therefore value, enabling authors to disseminate their



research and instigate new collaborations with partners in our community.

Each issue we are fortunate to be able to include high quality Evidence Summaries that are thorough, peer reviewed and well received by the readership. The Editor and Board would like to extend grateful thanks to the WHAM node and its authors for their incredible hard work in preparing these summaries and for allowing us to publish them within Wound Practice and Research.

Finally, this year we also, for the first time sent out an expression of interest for new members to join the Editorial Board. The aim was to provide transparency and opportunity for Wounds Australia members who were interested in increasing their involvement in editorial processes. There was an overwhelming response of very high-quality applicants whose proposals were assessed by a sub-group of the Board. I am very pleased to announce our new Board members are Dr Kathy Finlayson, Dr Sharon Latimer, Dr Peta Tehan, Dr Robyn Rayner and Dr Zlatko Kopecki. 


Wounds Australia National Conference 2018 Advancing Healing Horizons: Towards cutting edge in wound care



The Wounds Australia National 2018 Conference was held from 24 to 26 October 2018. The event had more than 900 delegates over 3 full days of pre-conference workshops, plenary and concurrent sessions and social activities.

The 2018 National Conference has been described by many as the best Wounds Australia conference to date The event provided excellent education and networking opportunity for all the attendees.



Wound Awareness Week 2018

Wound Awareness Week 2018 was carried out between 15 - 21 July across Australia. The website, media, eBlasts, social media and using promotional kits were used to spead the awareness

The scope of the project was to conduct Wound Awareness Week in 2018 to support Wounds Australia's strategic priorities in the awareness and advocacy domains, identify key messages and a call to action that is consistent with the awareness and advocacy priorities.

Promotional Kits

We sent out over 2,500 promotional kits to all over Australia, 260 of these were sent to pharmacies, 400 were sent to primary health care networks in SA and the remaining were sent to existing Wounds Australia members, previous members and supporters of the campaign.

Website Statistics

We managed to completely rebuild the website in-house and a great deal of general information on wounds was incorporated. The number of website visits increased from 800 to 7694, which was a 301% increase.



Media

We engaged the PR Company 50Acres to help deliver a highly targeted media strategy. This targeted a mix of mainstream and niche/trade media.

Political Engagement

A five-point-plan calling on the government to help reduce the burden of chronic wounds was released at the beginning of Wound Awareness Week. A number of politicians shared their support for the campaign throughout the week on social media.

Social Media

Over 176,800 people saw posts on social media from the campaign as compared to only 58,839 people in 2017. The number of followers on Facebook increased by over 1,000 during the week..





Wounds Australia Scholarships

Wounds Australia provides scholarships to our members annually. These scholarships support members to access and participate in professional development.

Scholarship Experiences

In March 2019 I was awarded a Professional Development scholarship from Wounds Australia. This support enabled me to travel from Cairns to Melbourne to attend the Wound Comprehensive Package short course offered by La Trobe University in Melbourne from May 13th to May 17th.

The five-day program offered Wound Fundamentals on the first day, with Wound Comprehensive 14th to 16th, and Wound Debridement on the final day. Fifteen healthcare professionals attended on this occasion including two podiatrists, an orthotics specialist and a neonatal intensive care unit nurse. We had come from workplaces that included private practice, Residential Aged Care, Community Health, Correctional Centres, Outpatient Clinics and Hospital wards. Three nurses had travelled from overseas to attend. My flight from Cairns to Melbourne of three hours and thirty minutes did not warrant mentioning!



I'm please I attended the five consecutive days. The Wound Comprehensive Package incorporates the latest research in wound healing and at a time when new information, new technologies and new products abound, the systematic comprehensive five-day structured approach served to steadily guide me through the complexities of wound care.

The week began with wound physiology and assessment, progressed through management principles and decision making, went on to complex aetiologies which included a visit to the hyperbaric chamber, then followed with lower limb ulceration and investigations, finishing with debridement on the last day. The program was delivered by presenters with an abundance of knowledge and experience, some experts in their fields, Melinda Brooks Nurse Practitioner, Dr Bill McGuiness Associate Professor/Wound CNC. All presenters were engaging, all encouraged us to contribute to the sessions with our own experiences and case studies. Despite a full timetable, there was time taken to address individual questions with many of these opportunities generating whole class discussions.

An unplanned highlight of the five-day course for me was an opportunity to catch up with Allan Donnelly, of Qcity Podiatry and Healthcare. Many of you will remember Allan for his presentation at the Wounds Australia Adelaide National Conference. Allan was the 2018 winner of the Innovation Tank Award for his work on developing a simple affordable technique to produce moulds that facilitate the production of orthotics for high risk foot patients. Allan, attending the short course also, willingly shared his years of experience and wealth of knowledge with the group adding an extra dimension and perspective to our case study discussions.

Attending the short course at La Trobe University enabled me to update and consolidate the knowledge and skills underpinning my scope of practice supporting me in my role as Clinical Nurse Atherton Wound Management Service. I look forward to not only sharing the information and materials from the course with colleagues, to promote education, support team members and update clinical practice guidelines in our workplace, but also with patients to ensure they receive best care in wound prevention and management.

Thank you to Wounds Australia for your ongoing support, I would not have got there without your assistance.

Healthy Leg Club Education Day for the Community of WA

The Pharmacy 777 Healthy Leg Club Education day, sponsored by Wounds Australia, increased awareness in the community on updated wound care, how to identify for chronic wounds and lower leg conditions. We, as pharmacists; Lusi Sheehan and Aaron Chan (Intern) informed about healthy skin and wound care, venous leg symptoms and compression therapy. We also shared resources and videos from Wounds Australia to spread key messages.

Our local podiatrist, Kate Thomson, provided education around checking your feet and footwear to protect and prevent from wounds and injuries. Finally, our local physiotherapist, Madeleine Stockden, spoke about lymphoedema, exercise and different types of compression therapy. Models and samples were used to demonstrate the concepts.

State Reports

Australian Capital Territory

Wounds Australia (ACT) 2019 has continued to function through the time and expertise provided by a small band of volunteers. I would like to thank them for their commitment and look forward to working with them in the future.

Membership numbers this Financial Year stand at 110 which has remained stable from previous years. Our AGM will occur within the next couple of months.

Education

The previous ACT Twilight event "Translating Evidence into Practice" was a successful evening with over 100 people attending the event. Nurse Educators at ACT Health, Tara Kuleas and Dimity Walsh discussed their Quality Improvement Project, focusing on growing confidence in Graduate Nurses in Wound Management Practices. Judith Barker, Nurse Practitioner at ACT Health presented the clinical update based on the recent publication on Aseptic Technique in Wound Dressing Procedure. There was also be a panel discussion on multiple Wound Challenge Case Studies. Panel Members included Alicia Spacek (Community Nursing Clinical Nurse Consultant), Cassie Luke (Community Nursing, Senior Nurse) and Anne Wilson (Plastics Advanced Practice Nurse).

The case studies facilitated quality discussions between panel members and the audience.

ACT is hosting a Two-Day Symposium on Friday 6th and Saturday 7th December 2019, Old Parliament House Canberra. The symposium will include the launch of the 2019 NPUAP/EPUAP and PPPIA International Pressure Injury Guidelines. The theme of the event is to "Protect your skin through thick and thin as well as overcome the barriers and transfer the evidence when preventing and managing pressure injuries." Registrations are currently open.

Other activities

Would Awareness Week saw many areas throughout ACT Health promote awareness through flyers and posters from the Wounds Australia promotional kit. The Canberra Hospital had numerous trade displays as well as a Wounds Australia table allowing both companies and committee members to engage with both the public and staff. The trade display tables allowed staff the opportunity to come and have a tactile look, ask questions and better understand the wound aetiology relevant to product use as well as product application and technologies. ACT Committee members promoted Wounds Australia membership, Standards for Wound Prevention and Management document and other evidence based practice.

Western Australia
